REVIEW OF PERFORMANCE OF THE CENTRE FOR RAILWAY INFORMATION SYSTEMS (CRIS) BY THE MINISTRY OF RAILWAYS FOR THE YEAR 2022-23.

The Centre for Railway Information System (CRIS) was constituted by the Ministry of Railways on 01.07.1986 as an autonomous body for computerization activities on Indian Railways. CRIS is an IT arm of Indian Railways (IR). As IR moves along its path of modernisation, the need for effective digitalisation is getting ever more critical, in which CRIS plays a pivotal role. Over the years, CRIS has taken up projects pertaining to all aspects of Railway working. The highlights of the work done during the year 2022-23 are as under:

The last year saw IR's applications move towards increased mobility through the use of mobile apps and hand-held terminals for Railway staff. Ten thousand HHTs (Handheld Terminals) were deployed in various trains across the country. User interfaces for Customers and staff were simplified and made more intuitive, and local languages continued to be introduced in ticketing applications. The M-UTS (Mobile –Unreserved Ticketing System) enabled tablet-based booking to ease queuing at crowded stations and provide ticketing services at halt stations.

The PRIMES and PRATIG applications developed under Passenger Reservation system (PRS) Modernisation work were further enhanced by adding RP (Reservation Period) and Tatkal analysis reports.

Participation in Gatishakti initiatives resulted in wider dissemination of information of Railway freight services across the logistics ecosystem in the country through the Freight Business Development portal. The Parcel Management System saw nation-wide deployment as well. Joint Parcel product (JPP) was deployed at about 75 stations in collaboration with Dept of posts.

A number of Electronic In-Motion weighbridges were integrated with FOIS (Freight Operations Information System) to enhance collection of data at source.

Following the tenets of Data governance; reconciliation and verification of the Wagon Master Database has been initiated. Similarly, under the MDMS (Master Data Management System) project, master data management of other databases was initiated as well.

In the COA (Control Office Application), data from RTIS (Real time Train information System) as well as REMMLOT (Remote Monitoring and Management of Locomotives and Trains) added up to nearly 40% of the entries made, thereby increasing the reliability of the application. As more RTIS devices are installed, the proportion of data captured automatically from source will increase.

Fresh profiles of over 9000 trains were finalised in Software Aided Train Scheduling and Network Governance (SATSaNG) and sent to Integrated Coaching Management Systems(ICMS) and other systems during the exercise done before launch of the new timetable. Simulation of bare runtime of Vande Bharat trains was completed for 6 routes using the inhouse developed Train Performance Calculator. SATSaNG was moved completely to the Elastic Beanstalk service on AWS cloud. The Crew Management System was integrated with Dedicated Freight Corridor Corporation of India Limited (DFCCIL)'s system.

The Geographic Information system (GIS) Map & Geospatial Database for IR assets was provided with a facility to edit and add data for field officials, both on-track, off-track asset & Land boundary for verification & correction of published data. An application was developed to provide a ready comparison of the map of any area over a period of time. Digitization of main line track alignment of 68 divisions is completed. Cleaning of data (station, yard line and land boundary) has been completed for 17 divisions.

In the IR Projects Sanctions and Management System/Works Programme Management System (IRPSM/WPMS), the contractor e-MB (Measurement Book) and Billing for Works Contracts were made live in selected Construction Units of Indian Railways. The IR-Works Contract Management System (IR-WCMS) (excluding Contractor e-MB) was made live in all Construction Units of Indian Railways as directed by Railway Board.

In rolling stock related applications, the thrust remained on generating Brake Power Certificates for carriage and wagon stock through the Freight and Coaching Maintenance Management Systems and their associated mobile Apps. Approximately 5.3 lakh coaching BPCS (Push-Button Constant-Speed Control) and 1.3 lakh freight wagon BPCS were generated through these systems in the last year. Radio-Frequency Identification (RFID) tagging was completed in 1,82,101 wagons and 18,533 coaches. Software for Loco Asset Management (SLAM) Application was made live in all 27 Electric loco sheds under SLAM roll out scope.

Unifying all procurement and contract management, catering and other earning contracts were also added in the EPS. Virtual Account Number (VAN) system for online EMD required for e-Auction was developed in collaboration with SBI as per mandate given by Railway Board.

The Finance Management applications were integrated with other IT applications for smooth flow of data across organisational boundaries. UTS-TAMS-IPAS (Unreserved Ticketing System – Traffic Accounts Management System- Integrated Payroll & Accounting system) integration have made errors related to coaching e-CR notes negligible. Users can see the draft bill before generating the final bill in the AOB (Accounts office Balance Sheet) module.

The HRMS was extended with the addition of more modules. The ePass module was made completely on-line as desired by Board. Several applications including HRMS (Human Resource Management System) were hosted on the CRIS private Cloud.

A few important Data Analytics, Artificial Intellitence/Machine Learning use cases were implemented. Notable ones are Ideal Train Profile, Unique PL Numbers, and Detention at Unmanned Level Crossings. A centre for Data Analytics was set up in Secundrabad.

As part of IT security, CRIS's Cyber Crisis Management Plan was approved by CERT-In (Indian Computer Emergency Response Team). Multi-Agency Audit (NAAT) by C-DAC (Centre for Development of Advanced Computing), Hyderabad, was completed.

The API (Application Programming Interface) Gateway (Pravah) provided AP|-based information interchange with partner organisations. About 1.3 crore interchanges were carried out monthly.

The accounts of CRIS for the year 2022-23 have been audited by the office of Comptroller and Auditor General of India.
