ANNEXURE-I

TERMS AND CONDITIONS FOR SALE OF VEHICLES AGAINST TENDER ENQUIRY NO. 2014/CRIS/NDLS-HQ/Admn/0054/Pt-1 Dated.07.03.2024.

1. Interested Parties may submit their highest price for vehicle individually in a sealed cover latest by 11.00 AM on or before 28.03.2024. The inner cover containing bid and other relevant documents along with DD/Pay Order/Bankers Cheque towards EMD should be sealed properly. The cover should be put in another Outer Cover and may be dropped in the Tender Box kept at Annexe-6 CRIS, New Delhi. Both the inner and the outer covers should be super scribed in Bold Capital letters.

"BIDS FOR SALE OF VEHICLE".

2. The sale of vehicle shall be strictly on AS IS WHERE IS BASIS" as per the RESERVE PRICE and no guarantee or certificate of its worthiness of quality will be given by this office. The condition of the vehicles can be inspected physically between 14.03.2024 to 27.03.2024 between 3:00PM to 4.00 PM at CRIS, Chanakyapuri. New Delhi-110021.
3. The bid should be accompanied by earnest money for Rs.1000/- The Earnest money can be deposited by Bank Draft in favour of CRIS New Delhi. The bank draft should be attached with the bid failing which the bid shall not be considered at all. If the highest tenderer/successful tenderer accepted by the competent authority in this Department fails to deposit the sale price within the prescribed time limit, his Earnest Money will be forfeited. In case the offer is withdrawn by any tenderer, the Earnest Money deposited by tenderer shall be forfeited.
4. EMD amount is payable by means of DD/Pay Order/Banker's Cheque in favour of CRIS, New Delhi. (Payment by Cheque/Cash shall not be accepted). Offers received without EMD amount shall not be considered at all by this office.
5. The successful bidder will be required to deposit the total bid amount by means of Demand Draft Pay Order/Banker's Cheque in favour of CRIS, New Delhi within seven working days of award of the contract.
6. EMD of the successful bidder(s) will be released only after realization of Sale precede amount. Earnest money Deposit of the bidders who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this office. EMD amount will not be adjusted in the Sale Amount accepted by CRIS. EMD of successful bidder(s) shall be released only after successful completion of the sale process.
7. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Pan Card/ Voters Identity Card/Aadhar Card in case of individual and Registration Certificate and Pan Card in case of firms etc.).
