## **ANNEXURE-I**

### **TERMS AND CONDITIONS FOR SALE OF VEHICLES AGAINST TENDER ENQUIRY NO. No.2013/CRIS/NDLS-HQ/Admn/2013/0017/Pt-1 Dated. 21.03.2023.**

1. Interested Parties may submit their highest price for vehicle individually in a sealed cover latest by 11.00 AM on or before 26.06.2023. The inner cover containing bid and other relevant documents along with DD/Pay Order/Bankers Cheque towards EMD should be sealed properly. The cover should be put in another Outer Cover and may be dropped in the Tender Box kept at Annexe-6 CRIS, New Delhi. Both the inner and the outer covers should be super scribed in Bold Capital letters

#### **"BIDS FOR SALE OF VEHICLE".**

2. The sale of vehicle shall be strictly on AS IS WHERE IS BASIS" as per the RESERVE PRICE and no guarantee or certificate of its worthiness of quality will be given by this office. The condition of the vehicles can be inspected physically between 14.06.2023 to 23.06.2023 between 3:00PM to 4.00 PM at CRIS, Chanakyapuri. New Delhi-110021.
3. The bid should be accompanied by earnest money for Rs.1000/- The Earnest money can be deposited by Bank Draft in favour of CRIS New Delhi. The bank draft should be attached with the bid failing which the bid shall not be considered at all. If the highest tenderer/successful tenderer accepted by the competent authority in this Department fails to deposit the sale price within the prescribed time limit, his Earnest Money will be forfeited. In case the offer is withdrawn by any tenderer, the Earnest Money deposited by tenderer shall be forfeited.
