1. <u>Scope of Work</u>: Open Tender is invited for disposal of old /obsolete/unserviceable IT and NON-IT Assets Disposal of old IT Assets (Servers, AIO,CPU, Printer,Photo copier machine, Router, Jack Panel, IT accessories, etc.,) on "AS IS WHERE IS BASIS".

2. Eligibility Criteria :

2.1 The bidders should be Authorized Dismantler/Recycler of E-Waste Registered with Central Pollution Control Board or State Pollution Control Committee for IT material (Annexure-II). Copy of documentary proof to be attached with the bid.

3. <u>Inspection of Items</u> :

The inspection of material can be done by the prospective bidder at CRIS/HQ, Chanakyapuri, New Delhi-110021 from 21^{st} Aug 2023 to 1^{st} September 2023 on any working day between 3.00 PM to 6.00 PM.

4. <u>Other Terms and Conditions</u>

- 4.1 The disposal of old items shall be strictly on "*AS IS WHERE IS BASIS*" and no guarantee or certificate of its worthiness or quality will be given by this office.
- 4.2 The bid should be accompanied by prescribed EMD, payable by means of DD/Pay Order/Banker's Cheque in favour of CRIS, New Delhi (Payment by cheque/cash shall not be accepted.) EMD amount will not bear any interest.
- 4.3 Bid without EMD enclosed shall be summarily rejected. However the firms registered with NSIC/MSME are exempted from the payment of EMD for which a copy of valid certificate must be submitted as proof of exemption.
- 4.4 The Successful bidder will be required to deposit the total bid amount through Demand Draft/Pay Order/Banker's cheque in favour of CRIS, New Delhi within seven working days of intimation of acceptance of bid by CRIS. EMD amount shall be returned after the bid value is deposited and material is removed as per terms and conditions.

- 4.6 If the highest quoting bidder fails to honor the bid, opportunity will be given to the next highest quoting eligible bidder (H-2) provided it is prepared to accept the price offered by the H-1 bidder.
- 4.7 The delivery of the items will be arranged only after the successful bidder submits documentary evidence in support of registration i.e. Registration Certificate, GST number and PAN Card of firm.
- 4.8 The material will be removed by the successful bidder(s) within 15 working days from the date of issue of acceptance of bid. No assistance/transportation will be provided by CRIS. Delivery of material will be given to the successful bidder or his representative on working day during 10.00 AM to 6.00 PM. Delivery of material from CRIS premises will not be allowed on holidays/Saturdays and Sundays.
- 4.9 EMD of the firms rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of CRIS shall be final in this regard.
